說明：

一、緣本公司因最終控制股東由PineBridge Investments, L. P. 變更為MetLife, Inc.，經金融監督管理委員會（下稱「金管會」）於中華民國（下同）115年3月31日以金管證投字第1150334608號函核准本公司更名（詳附件一）。本公司名稱將由「柏瑞證券投資信託股份有限公司（PineBridge Investments Management Taiwan Limited）」變更為「大都會證券投資信託股份有限公司（MetLife Investment Management Taiwan Limited）」，更名基準日謹訂於115年10月1日。

二、另依據境外基金管理機構轉知，本基金擬修訂公開說明書，將修訂下列基金相關事項：

（一）本基金之基金管理機構名稱由「柏瑞投資愛爾蘭有限公

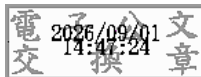

Dear Investor,

The purpose of this letter is to notify you of a number of non-material changes that will be made to the prospectus for the Fund (the "Prospectus") and supplements for the Sub-Funds (each a "Supplement") and the applicable local covering documents (together the "Offering Documents"). The changes to be made to the Offering Documents (the "Changes") are summarised in the Appendix to this letter.

As previously informed in the notice to the investors dated 5 January 2026, the change in ultimate controlling shareholder of PineBridge Investments Ireland Limited (the "Manager"), the Investment Managers and Sub-Investment Managers of the Fund took place on 30 December 2025 (the "Controlling Shareholder Change"). Following the Controlling Shareholder Change, the Fund, Sub-Funds, and the Manager will be renamed as set out below following the Manager's acquisition in December 2025 by MetLife Investment Management, the institutional asset management business of MetLife, Inc., which has become the new ultimate controlling

shareholder of the Manager.

- The Fund will change its name from "PineBridge Global Funds" to "Metropolitan Global Funds"
- Each Sub-Fund will change its name by replacing "PineBridge" with "Metropolitan", as set out in Annex I to the Appendix to this letter. For example, "PineBridge Global Focus Equity Fund" will be renamed "Metropolitan Global Focus Equity Fund"
- The Manager will change its name from "PineBridge Investments Ireland Limited" to "MetLife Investment Management Ireland Limited"
- The Sub-Investment Manager, PineBridge Investments Singapore Limited ("PBIS"), will change its name to "MetLife Investment Management Singapore Limited"
- The asset holding vehicle for PineBridge India Equity Fund (which is to be renamed as Metropolitan India Equity Fund) will change its name from "PineBridge Investments GF Mauritius Limited" to "MetLife Investment Management GF Mauritius Limited"

In addition, the Investment Manager, PineBridge Investments Asia Limited, will no longer maintain its present Chinese name. For the avoidance of doubt, the English name of PineBridge Investments Asia Limited remains unchanged.

The Changes are non-material, do not result in any change to the Investment Objectives and Policies of the relevant Sub-Funds and do not require any action on your part. Unless otherwise specified, the Changes will become effective on or around 30 November 2026 and in any event no earlier than 3 months following the date of this letter (the "Effective Date").

The updated Offering Documents, including the Product Key Facts Statement ("KFS") of the SFC-authorized Sub-Funds for Hong Kong investors, will be available, free of charge from the Manager or the Fund's Administrator and Transfer Agent, State Street Fund Services (Ireland) Limited, and from the offices of PineBridge Investments Asia Limited, the Fund's Hong Kong representative (for Hong Kong investors) and PineBridge Investments Singapore Limited, the Fund's Singapore representative (for Singapore investors) during normal office hours. The updated Offering Documents, including the KFS of the SFC-authorized Sub-Funds for Hong Kong investors, will also be available on www.pinebridge.com¹ (and for Hong Kong investors on www.pinebridge.com.hk¹).

- c) The Supplement of PineBridge India Equity Fund (which is to be renamed as Metropolitan India Equity Fund) will be amended to (i) replace the name of "PineBridge Investments GF Mauritius Limited" with the new name of "MetLife Investment Management GF Mauritius Limited"; (ii) remove the duplicative reference to Class R2H³ and Class R7H³ from the Supplement Unit Description Table; and (iii) appoint PBIS to act as sub-investment manager with effect from 30 November 2026 ("PBIS Appointment Date").
